
May 21 2008 The Honorable S. Thomas Anderson assumed duty as a United States District Judge on *May 21 2008* thereby necessitating a reassignment of his Magistrate Judge cases, including both civil cases and criminal cases as well as cases in which Judge Anderson has been serving as either the presiding judge or as the referral judge in both the Eastern and Western Divisions, to Magistrate Judge Diane K. Vescovo and Magistrate Judge Tu M. Pham. In furtherance of these reassignments, it is hereby

ORDERED, that the cases set forth on "Attachment I" and "Attachment II" be reassigned from the docket of Judge Anderson (in his former capacity as a Magistrate Judge) to the dockets of Magistrate Judge Diane K. Vescovo and Magistrate Judge Tu M. Pham. These cases shall be reassigned one-half each in alternating case number fashion to Judges Vescovo and Pham and shall carry the case designation of either "VX" or "PX", the former referring to those cases reassigned from Judge Anderson to Judge Vescovo and the latter referring to those cases reassigned from Judge Anderson to Judge Pham. The "X" designation will identify reassigned cases that will ultimately be reassigned again to the dockets of the District Court's replacement Magistrate Judge.

The lists of cases attached hereto as "Attachment I" and "Attachment II" are hereby incorporated by reference in full herein as a part hereof for any and all purposes relevant to the execution of this Administrative Order, and it is

ORDERED FURTHER, that the Clerk shall enter this Order upon the record of this Court and shall update each of the dockets for those cases listed on "Attachment I" and "Attachment II".
